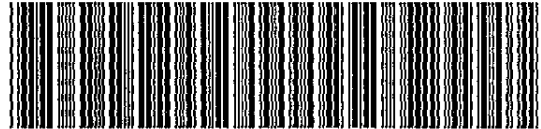

The Corporation will indemnify those listed above in the Board of Directors or anyone who enters into a contract on behalf of this corporation as long as the Board of Directors has approved the contract.

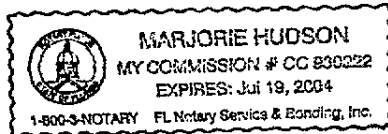
