Recently I accessed the Florida Department of State internet web site to complete and submit the 2006 Annual Report for Toxicologic Pathology Associates, Inc. (TPA). Upon entering the appropriate company information, the system indicated that I could not access the 2006 Annual Report due to the fact that TPA's corporation status was "inactive". Since I was completely unaware of this, I obtained the telephone number for the Florida Corporation Annual Reports division and promptly called them to inquire about this situation.

Upon calling the Corporation Annual Reports division, my call was transferred to the Reinstatement division where I spoke with Mr. Tyrone Scott. Mr. Scott informed me that TPA's status was changed to inactive due to failure to file the 2005 Annual Report. I explained to Mr. Scott that I had never received any notification that this report was required to be filed for 2005, nor was I notified that TPA was delinquent in not filing the 2005 Annual Report and I also did not receive any notification that TPA was being changed to inactive status. I further explained that TPA was incorporated in Florida on May 13, 2004, but did not begin doing business in Florida until August 1, 2005. In July 2005 on behalf of TPA I submitted an on-line business registration and application to collect and/or report tax in Florida. I subsequently received a letter dated July 28, 2005 notifying me of the approval of the application and assignment of an unemployment account number. At no time throughout this process was I ever made aware of the delinquency of the 2005 Annual Report.

TPA has made every effort to comply with the requirements to do business in Florida, we simply were not aware of the requirement to file a 2005 Annual Report since we had not actually begun to do business in Florida until 2005 and I had not received any notification that this report was due for the year ended December 31, 2004. I asked Mr. Scott what actions were necessary to restore TPA's active status. Mr. Scott informed me that he would send me Corporation Reinstatement form and that I needed to complete this form and return it in accordance with the instructions provided. Mr. Scott further instructed me to include a check in the amount of \$300 (\$150 for the 2005 Annual Report and \$150 for the 2006 Annual Report) plus an optional \$8.75 if I desired to receive a certification of status, and to include a letter explaining the circumstances and requesting a waiver of the applicable reinstatement fees. Accordingly, I am enclosing with this letter the completed Corporation Reinstatement form and a check in the amount of \$308.75.

Please notify me if you have any questions or if I need to take any additional actions at this time. I appreciate your consideration of this request and I will await further instructions or receipt of Certification of Status. Thank you for your assistance and cooperation.
