ARTICLES OF INCORPORATION OF TEROMAC CORP.

THESE ARTICLES OF INCORPORATION are hereby adopted by the undersigned incorporator of this corporation for pecuniary profit under the Florida Business Corporation Act.

ARTICLE I

NAME AND LOCATION OF AGENT AND OFFICES

- 1.1 Name. The name of the corporation shall be TEROMAC CORP.
- 1.2 Principal Office and Mailing Address.
