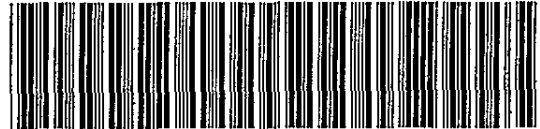

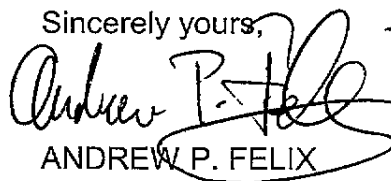

WE, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation for profit under the laws of the State of Florida.

ARTICLE I
NAME

The name of the corporation is MOORE TRUCKS, INC.

ARTICLE II
DURATION

The term of existence of this Corporation shall commence on the 6TH day of May, 2004, and shall be perpetual.
