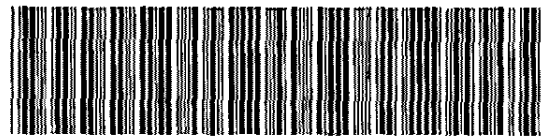

ARTICLES OF INCORPORATION

of

ARTICLE I. NAME. The name of the corporation shall be **SPCO HOLDINGS, INC.**

ARTICLE II. DURATION. The corporation shall exist perpetually.

ARTICLE III. PURPOSE. the purpose of this corporation is to consult to and manage other businesses and for the purpose of the transaction of any other lawful business for which corporations may be incorporated under the laws of the State of Florida.



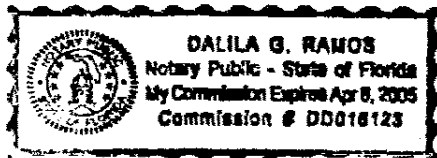
