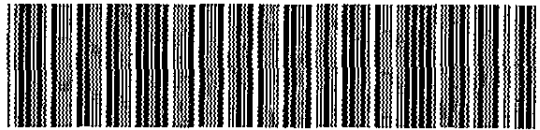

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of the corporation is:

ARTICLE X - AMENDMENT

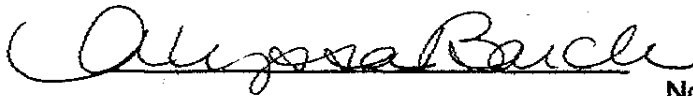

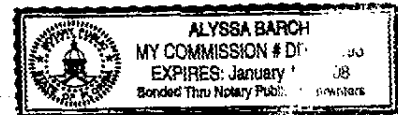

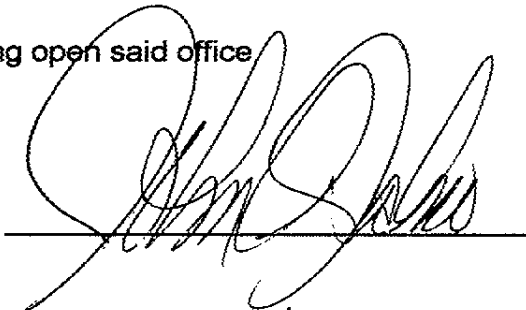
