ARTICLES OF INCORPORATION OF HOME INVENTORY CONCEPTS, INC.

The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

ARTICLE I Name

The name of the Corporation shall be Home Inventory Concepts, Inc.

ARTICLE II Principal Office

The principal office of the Corporation is located at 710 Wing Foot Lane, Melbourne, Florida 32940, and its mailing address is the same.

ARTICLE III Corporate Purposes, Power and Rights
