ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of **TEST BALANCE & ENGINEERING SERVICES, INC.**, under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME
