

PLAN OF MERGER

The following plan of merger is submitted in compliance with section 607.1101, Florida Statutes.

First: The name and jurisdiction of the surviving corporation is:

VRH Resources Corp.	Florida

Second: The name and jurisdiction of the merging corporation:

ACN Resources Corp.	Florida

Third: The terms and conditions of the merger are as follows:

1. The constituent corporations, VRH Resources Corp. (the "Surviving Corporation") and ACN Resources Corp. (the "Merging Corporation"). shall, pursuant to applicable provisions of the Florida Business Corporation Act, be merged with and into a single corporation, to wit, VRH Resources Corp. Upon the date of filing of the Articles of Merger with the Florida Department of State (the "Effective Date"), the Surviving Corporation shall continue to exist under its present name pursuant to the provisions of the laws of the State of Florida and the separate existence of the Merging Corporation shall cease in accordance with the provisions of the Florida Business Corporation Act.

2. The Articles of Incorporation and the bylaws of VRH Resources Corp. upon the Effective Date of the merger shall be the Articles of Incorporation and the bylaws of the Surviving Corporation and shall continue in full force and effect until changed, altered or amended as therein provided and in the manner prescribed by the provisions of the Florida Business Corporation Act.

3. The director and officer in office of the Surviving Corporation upon the Effective Date shall continue to be the director and officer of the Surviving Corporation, whom shall hold his directorship and office until the election and qualification of his respective successor or until his tenure is otherwise terminated in accordance with the bylaws of the Surviving Corporation.

4. The Board of Directors of each of VRH Resources Corp. and ACN Resources Corp. are authorized to amend the Plan of Merger at any time prior to the Effective Date, subject to the limitations set forth in Section 607.1103(8).

Fourth: Each issued share of the Merging Corporation shall, upon the Effective Date of the merger, be surrendered and cancelled and no new shares of the Surviving Corporation shall
