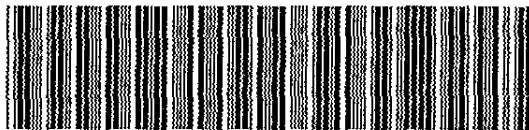

Name

The name of the corporation is GLEN LAU FILM & VIDEO, INC.

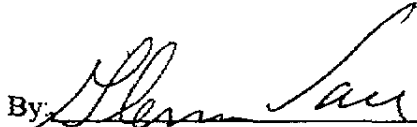

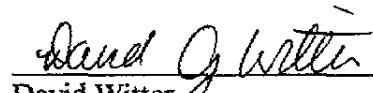

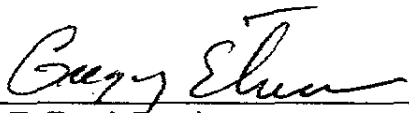
