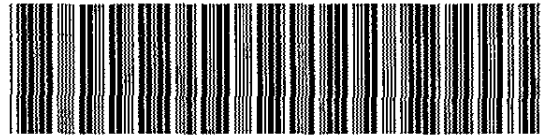

ARTICLES OF INCORPORATION

PINTA CORPORATION

The undersigned, for the purpose of forming a corporation pursuant to the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes, do hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the Corporation is Pinta Corporation.

ARTICLE II

TERM OF EXISTENCE

Existence of the Corporation shall be perpetual. Corporate existence shall commence upon the filing of these Articles of Incorporation.

ARTICLE III

NATURE OF BUSINESS

The purpose for which the Corporation is initially organized is the transaction of any and all business for which Corporations may be incorporated under the provisions of Chapter 607, Florida Statutes, including the provision of professional medical services.

ARTICLE IV


