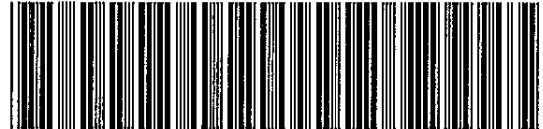

**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is GLOBAL YOUTH SERVICES, INC. and the principal address and principal place of business is 5868 TROPHY LOOP, LAKELAND, FLORIDA 33811.

ARTICLE II - REGISTERED OFFICE AND AGENT
