I am the owner of Aaron D. Delgado, P.A., a law firm based primarily in Volusia County, Florida.

On October 15, 2024, I received notice that from a credit report that a phone number had been opened in my name. I searched that number online and found it went to a website (AARON D. DELGADO P.A. (aaron-d-delgado-pa.org)) which is not my company website but instead is a "clone" or "skin" of my website (www.communitylawfirm.com). The fake website is registered to a foreign corporation. The address on the website is a St. Petersburg, Florida address which I do not have any connection with. I have asked my IT department to report this "fake" site to the domain registrar.

On October 16, 2024, I received an email from the Florida Division of Corporations that my information had been updated. An "update" was filed – fraudulently – changing my business address to the fake St. Petersburg, Florida address which has no relationship to my business. I contacted the Division of Corporations and was told to file an amendment online reverting the address, which I did.

Today, October 18, 2024, I received another email from the Florida Division of Corporations that my information had again been updated. An "update" was filed – fraudulently – changing my business address to the fake St. Petersburg, Florida address which has no relationship to my business. I contacted the Division of Corporations and was told to file an amendment online reverting the address, which I did for the second time in a week.

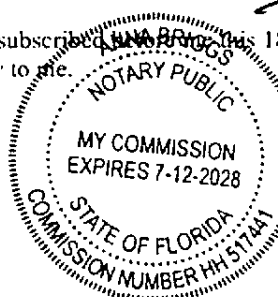
At no point did I authorize any changes to my corporate information, I do not have an office in St. Petersburg, that website is not authorized and I am the victim of (attempted) identity theft. I have notified the Florida Bar in case other law firms have been targeted. At this present time, the only correct address for my corporation is the address on the letterhead (227 Seabreeze) which has been my address for almost 20 years.

I have notified local law enforcement.

The foregoing is all true and correct, under penalty of perjury.
