#### ARTICLES OF INCORPORATION

**OF**

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

## ARTICLE I NAME AND PRINCIPAL OFFICE

The name of this corporation is Williams Cleaning & Home Repairs, Inc., and its principal office is located at 7511 Stage Coach Road, Pensacola, Florida 32526, and its mailing address is 7511 Stage Coach Road, Pensacola, Florida 32526.
