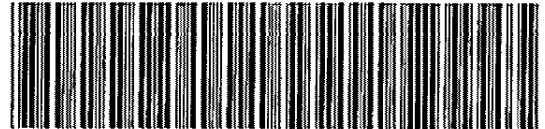

ARTICLES OF INCORPORATION
OF
COMMUNITY PARKING ENFORCEMENT, INC.

The undersigned incorporator for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST: The name of the corporation is COMMUNITY PARKING ENFORCEMENT, INC., a Florida Corporation (the "Corporation").
