Gladys Reyes shall be the President, Secretary and Director of the corporation.

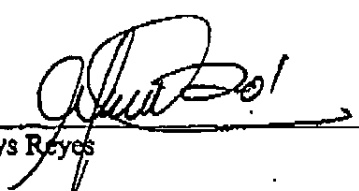
