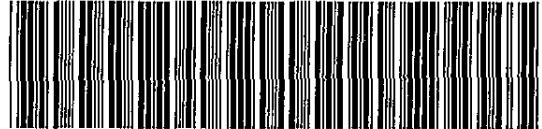


ARTICLE EIGHT
