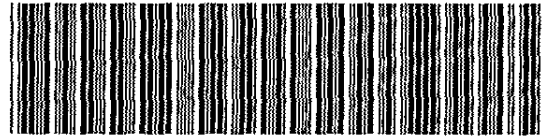



ARTICLE I - NAME

The name of this corporation shall be:

GULF COAST WOOD WORKERS, INC.


