




Dear Sir or Madam:

Our accountant had sent us our annual report to be signed and sent in with a check about a week and a half ago. They had sent it back in an envelope with our book work that they had completed for March. I just opened that envelope today because I was going to file the balance sheets and income statements in our binders. Unfortunately, in the envelope was the annual report that I see was to be filed by May 1 otherwise there would be a severe penalty. I listened to your automated phone message in regards to the statutory provision in regards to the late fee. I am begging the state not to charge us the late fee as this was not an intentional untimely payment. Four-hundred dollars is an excessive amount of money to a small business like ours that is already facing **major financial struggles due to a state road construction project**. We are located on Beach Blvd. in Jacksonville between Hodges and Kernan which has been under major road construction for over a year with another year to go. The project has our retail sales down by 65%. We are so strapped cash flow wise that today I tried to file our annual report online and was unable to do so because the available amount on our credit line was not enough to cover the \$550. You can probably verify this checking your website.

I am begging the state for mercy on the late fee, please see what can be done. I can assure you this will not happen again. If the person reading this is not authorized to approve this please take it to someone who has that authority.
