ARTICLE IV TERM

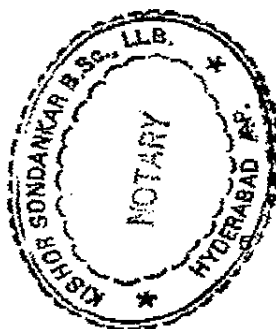
This corporation shall have perpetual existence.

6. **ARTICLE VI CAPITAL**

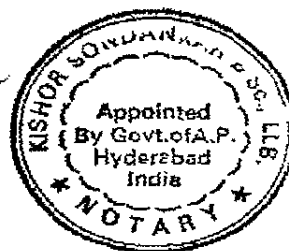

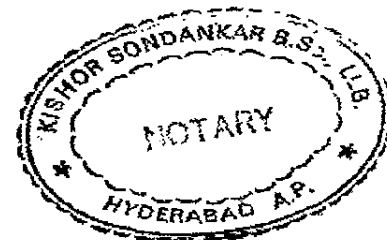
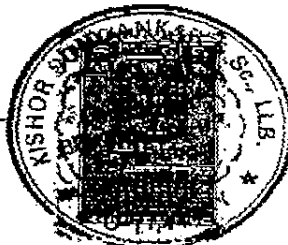
