Name and Duration

The name of the Corporation is B.J. Schaffner, M.D., P.A. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE II

Principal Office

The address of the principal office of the Corporation is 12435 Lake View Lane, Clermont, Florida 34711.

ARTICLE III

Registered Office and Agent
