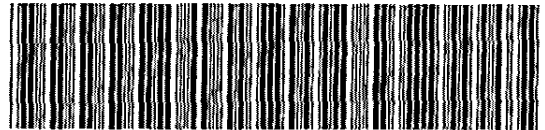

Article I: Name
