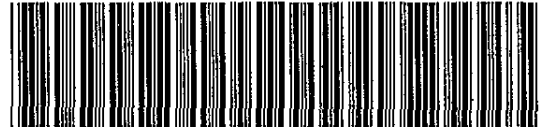

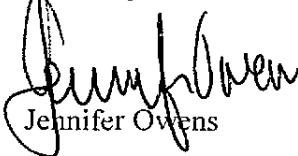

ARTICLES OF INCORPORATION
OF
ALAN TAYLOR CONSULTING, INC.

The undersigned subscriber to these Articles of Incorporation, being of full legal age, hereby presents these Articles of Incorporation to Florida Department of State, Division of Corporations with the intention of forming a corporation under and by virtue of the General Laws of the State of Florida authorizing the formation of corporations.

Article I

NAME

The name of the Corporation is Alan Taylor Consulting, Inc. (hereinafter the "Corporation").

Article II

NATURE OF BUSINESS

The purposes for which the Corporation is formed are:

To provide general consulting, public relations and marketing services and to conduct any and all business as may be permitted by the General Laws of the State of Florida. To do everything necessary, suitable and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinbefore set forth, either alone or in association with other corporations, firms or individuals, and to do every other act or acts incidental to or growing out of or connected with the aforesaid objects or purposes, provided the same be not inconsistent with the laws under which the Corporation is organized.

The Corporation shall be authorized to exercise all of the powers, rights and privileges granted to, or conferred upon, corporations of a similar character by the General Laws of the State of Florida now or hereafter in force, and the enumeration of the foregoing powers shall not be deemed to exclude any powers, rights or privileges so granted or conferred. The Corporation may conduct its business within and without the State of Florida.

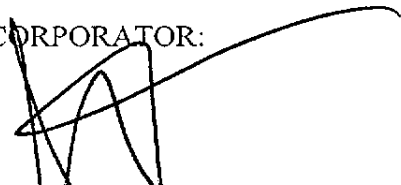
