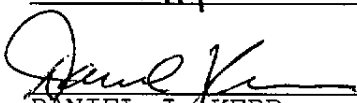
ARTICLE VIII TERM OF EXISTENCE

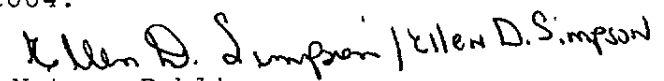
