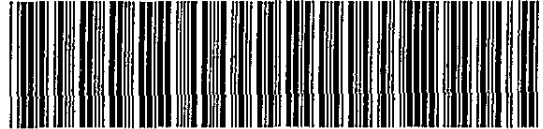

The initial registered agent is Allan Dees. The initial registered office of the corporation is 3510 Lawrence Rd., Orange Park, FL 32065.




