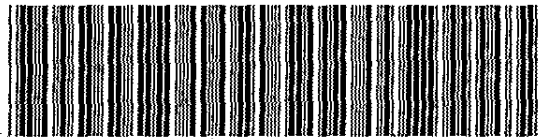


## ARTICLE X. INDEMNIFICATION
