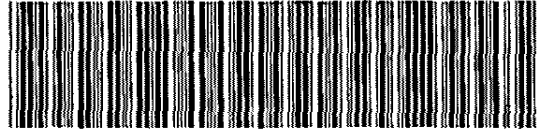

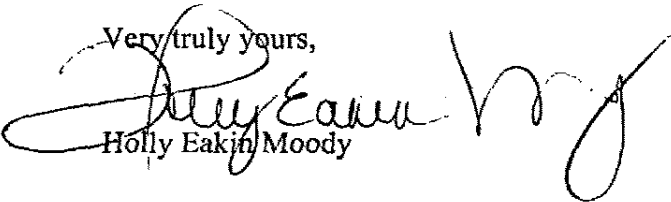

ARTICLES OF INCORPORATION

ARTICLE I

The name of this corporation shall be:

J & J Coin Laundry, Inc.

ARTICLE II

PRINCIPAL OFFICE

The principal office of this corporation shall be at:

ARTICLE III

DURATION

The corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE IV

PURPOSE

This corporation is organized for the following purposes:

- a) To manufacture, purchase or otherwise acquire, own, mortgage, pledge, lease, sell, assign and transfer, or otherwise dispose of, to invest, trade, deal in and deal with, goods, wares, and merchandise and real and personal property of every class and description.

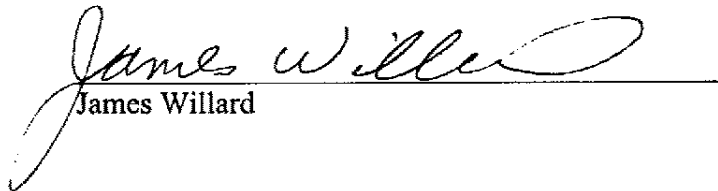

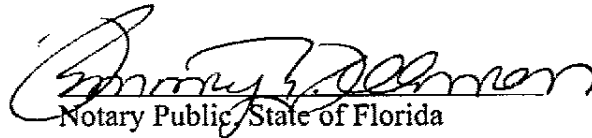

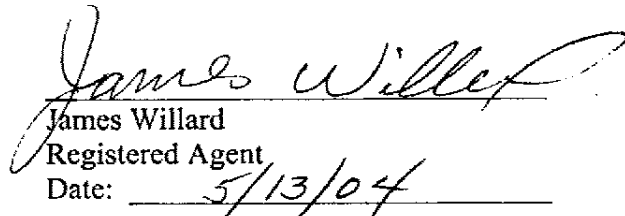
