Capital Stock


**ARTICLE X**

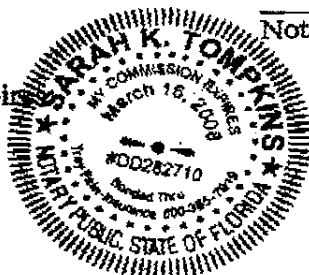
