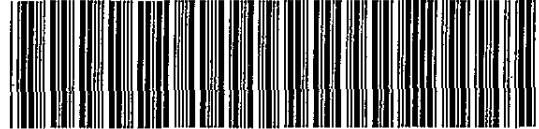




ARTICLE EIGHT




