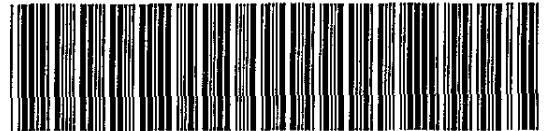

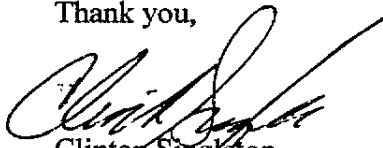

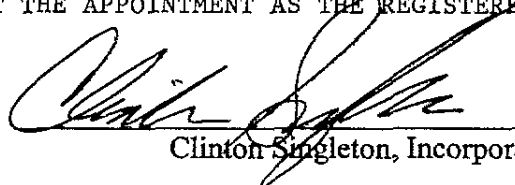
Shareholder shall have the right to maintain the same fractional interest in the incorporation by purchasing a proportionate number of shares of any additional issuances of stock.
