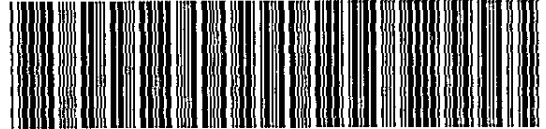

The undersigned subscriber to these Articles of Incorporation, a person, competent to contract, hereby sets forth his intention to incorporate under the laws of the State of Florida.

**Article 1. Name.** The name of this corporation is **HIGH CARD, INC.**

**Article 2. General Purpose.** This corporation is organized for the purpose of transacting any and all lawful business for which a corporation may be incorporated under the laws of the State of Florida.

**Article 3. Capital Stock.** This corporation is authorized to issue one thousand (1,000) shares of One Dollar (\$1.00) par value common stock.

**Article 6. Incorporator.** The name and address of the person signing these articles is **Richard S. Fitzpatrick**.


**Article 7. By-Laws.** The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and Shareholders of this corporation.



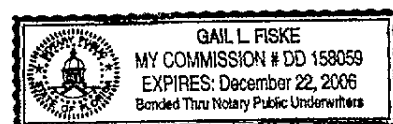
