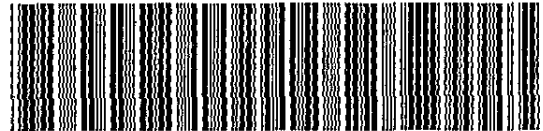

The undersigned Incorporator desiring to form a Corporation in accordance with chapter 607 of the Florida Statutes and adopt the following Articles of Incorporation:

**I. NAME**
