First Amendments adopted:

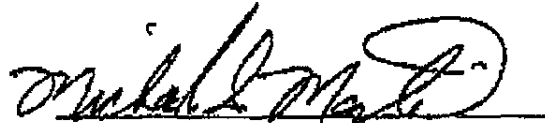
