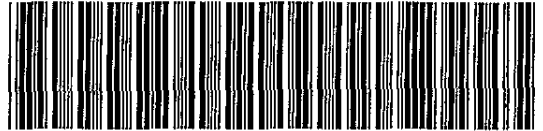

CORPORATE EXISTENCE

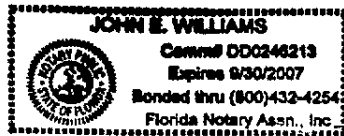
The Corporation shall commence on the date when the Secretary of State issues a Certificate of Incorporation to this Corporation and the same shall have perpetual duration.
