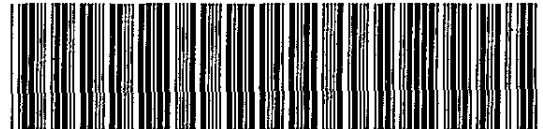

**ARTICLES OF INCORPORATION  
OF  
BILLING INTERNATIONAL GROUP, INC.**

**ARTICLE I - NAME**

The name of the corporation formed pursuant to these Articles of Incorporation is Billing International Group, Inc.

**ARTICLE II - DURATION**

The corporation shall exist perpetually, commencing on the date of filing of these Articles of Incorporation with the Secretary of State, State of Florida.

The corporation shall indemnify any officer or director or any former officer or director to the full extent permitted by law.


### **ARTICLE XI - AFFILIATED TRANSACTIONS**




