THAT EFFORT RESULTED TO ALL THE CARDS WERE BEING MAILED TO EACH CORPORATION'S; BY MARCH 31ST, 2006. SOME OF THE CORPORATIONS RECEIVED A POSTCARD, "STATING; THAT THE POSTCARD WAS TO BE MAILED BACK. IN ORDER TO RECEIVE THE UNIFORM BUSINESS REPORT OR TO FILE THE FORM ON THE INTERNET.
