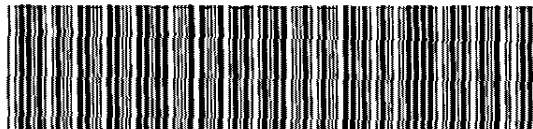

**ARTICLE I - NAME**

The name of this Corporation is: J D's Pub Inc.

**ARTICLE II - PURPOSE**

This corporation shall have perpetual existence and may engage in any and all lawful business under the laws of the United State and the State of Florida.


