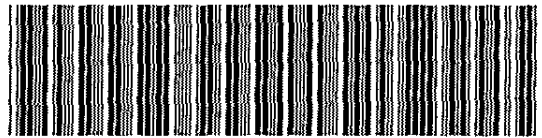

ARTICLES OF INCORPORATION OF TEAAM Corp

In compliance with the requirements of Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is TEAAM Corp.

ARTICLE II

Existence of the corporation will begin when the Articles of Incorporation have been filed.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is one thousand (1000) shares, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon all matters on which shareholders have the right to vote.

ARTICLE IV

The principal place of business of the Corporation is 221 Tanner Rd., Florahome, Florida, 32140 and the Corporation's mailing address is the same. ARTICLE VI

ARTICLE VII

The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.

ARTICLE VIII

The corporation through its directors and shareholders reserve the right to file a Subchapter S election with the Internal Revenue Service.
