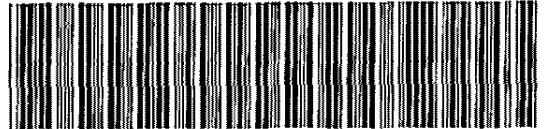

**ARTICLES OF INCORPORATION  
ACCESS PATROL SECURITY, INC.**

**ARTICLE I**

The name of the corporation is Access Patrol Security, Inc. (hereinafter called the "Corporation").

**ARTICLE II**

The address of the principal office and the mailing address of the Corporation is c/o 3025 Holland Dr. Orlando, Florida 32825.

**ARTICLE III**

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:


#### **ARTICLE VII**
