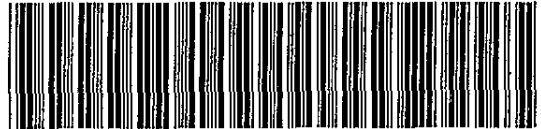

ARTICLES OF INCORPORATION
of
INSURANCE COMPLIANCE EXPERTS, CORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is:
INSURANCE COMPLIANCE EXPERTS, CORPORATION

ARTICLE II

PRINCIPAL OFFICE

The street address of the initial principal office of the corporation is 1445 Valley Pine Circle, Apopka, FL 32712. The mailing address of the corporation is the same.

ARTICLE III

CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE IV

PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

1. To transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
2. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.

ARTICLE V

CAPITALIZATION

The total number of shares of stock which the corporation is authorized to issue is fifteen thousand (15,000), all of which shall be Common Stock, with the par value of One Dollar

The holders of shares of the corporation shall have preemptive rights to subscribe or purchase from the corporation any shares authorized but unissued, or any newly authorized shares.

ARTICLE VII

REGISTERED OFFICE AND AGENT

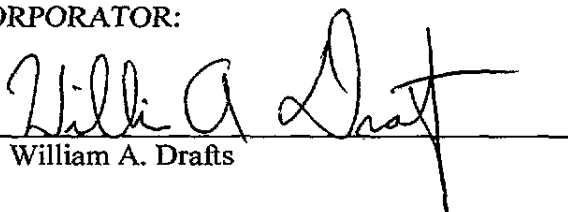

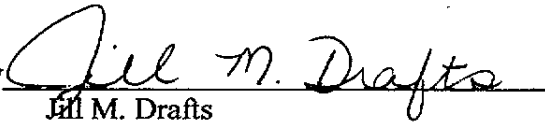
