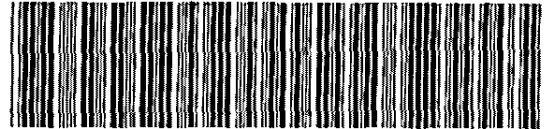

ARTICLE I—NAME

The name of this corporation is BRVENIK AND ASSOCIATES LAW FIRM, P.A.

ARTICLE II—DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

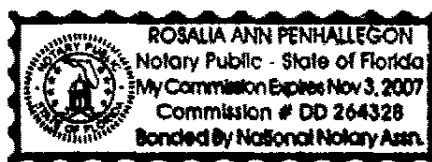
