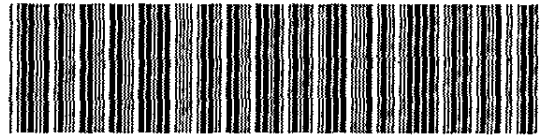



ARTICLES OF INCORPORATION
OF
CERTIFIED GLOBAL INSPECTIONS, INC..

We, the undersigned, hereby associate ourselves together and make, subscribe, acknowledge and file these Articles of Incorporation with the Secretary of State of the State of Florida for the purpose of becoming a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be: CERTIFIED GLOBAL INSPECTIONS, INC.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and of Florida. The general nature of the business to be transacted by this corporation shall include, but shall not be limited to, the following:

- A. To engage in the business of home inspections.
- B. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE IV

The maximum numbers of shares of stock shall be 500 of the par value of One Dollar (\$1.00) per share, all of which shall be common stock.

ARTICLE V

The amount of capital with which this corporation shall begin business is not less than Five Hundred Dollars (\$500.00).

ARTICLE VI

The principal office of the corporation shall be located at 18161 NW 82 AVE., MIAMI, FL 33015, but the corporation shall have the power to establish branch offices and other places of business at such other places within or without the State of Florida as may be determined or deemed expedient.

There shall be a Board of Directors for this corporation which shall consist of not less

than TWO and not more than five (5) persons, the number of same to be fixed by the Board of Directors by the corporate By-Laws. A quorum for the transaction of business shall be a majority of the directors qualified and active, and the act of a majority of the directors present at a meeting at which a quorum is present shall be the act of the directors. Subject to the by-laws, and meetings of the directors may be held within or without the State of Florida. Directors need not be stockholders.

ARTICLE VIII

The names and post office addresses of the members of the first Board of Directors, who, subject to these Articles, the By-laws of the corporation and the laws of the State of Florida, shall hold office for the first year of the corporation's existence, or until an election is held by the stockholder for the election of permanent directors, or until their successors have been duly elected and qualified, are:

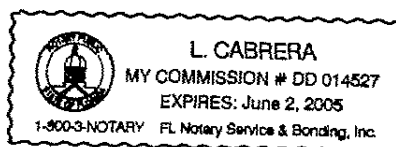
