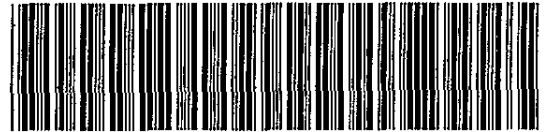



The aggregate number of shares which the corporation shall have authority to issue is one hundred (100) of no par value.


**ARTICLE FIVE**
