## ARTICLES OF INCORPORATION

### ARTICLE I - NAME

The name of this Corporation is GREAT POINT HOSPITALITY GROUP, INC.

#### ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing as of May 24, 2004.


