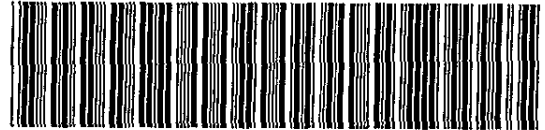

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME

The name of this Corporation is JFM SUBS, INC.

ARTICLE II-PRINCIPAL OFFICE

The street address of the initial principal office and mailing address of this Corporation shall be: 9090 Alexandra Circle, Wellington, Florida 33414.

ARTICLE III-PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business.
