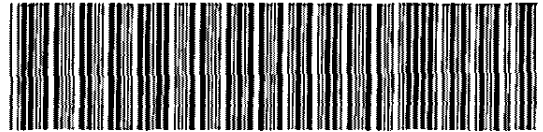

**CERTIFICATE OF INCORPORATION
CHULIZ MULTIPLE SERVICES, CORPORATION**

We, the undersigned, in order to form a Corporation for profit for the purpose hereinafter state, under the pursuant to the provision of the Florida Statutes, do hereby subscribed to this certificate of Incorporation, and do adopt the following Articles of Incorporation

ARTICLES OF INCORPORATION

ARTICLE I

The name of Corporation shall be:
CHULIZ MULTIPLE SERVICES, CORPORATION

ARTICLE II

The general nature of the business and the objects and purposes to be transacted and carried on by this corporation shall be:

- a. This Corporation is organized with the purpose to engage in multiple services, office work and all other lawful related activities permitted under the laws of the State of Florida and the United States of America.
- b. To enter into, make and perform contracts of any person, firm association or corporation, town, city, country, state, territory or government.
- c. To purchase or otherwise acquire, and to hold, own, maintain or otherwise dispose of an deal in lands and leaseholds, and any franchises, rights in real property, and personal or mixed property, and any rights, licenses or privileges necessary, convenient or appropriate for any of the person, whether as principals, agents trustees otherwise.
- d. - f. ARTICLE III

The maximum number of shares of stock which this corporation shall have outstanding any time shall be five hundred shares all of which shall be \$10.00 per value and each of which shares shall be issued fully paid and non-assessable, and shall be payable in lawful money of the United States of America, or in service of property at just valuation, to be fixed by the Director of this Corporation at the organizational meeting, or any other meeting held for that purpose.

ARTICLE IV

ARTICLE V

This Corporation is to have perpetual existence.

ARTICLE VI

ARTICLE IX

The names and post office addresses of the subscribers to the Certificate of Incorporation and the number of shares each agrees to take and the value of the consideration paid thereof, the total aggregate amount of capital which the corporation will begin business, is as follows

ARTICLE X

The management and control of the business of the Corporation shall be conducted under the directions of the Board of directors by officers who shall be elected by the Board of Directors, to-wit; a president, one or more Vice-president, a treasurer, and a Secretary, one or more of said officers may hold one or more officer except that the President may not also be the Secretary of Assistant Secretary. 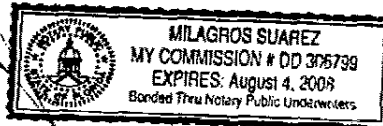


