ARTICLES OF INCORPORATION

OF

NEIDER-MOTLOW CONSTRUCTION COMPANY

I, the undersigned natural person of the age of eighteen (18) years or more, acting as incorporator of a corporation under the Florida General Business Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

The name of the Corporation is NEIDER-MOTLOW CONSTRUCTION COMPANY

ARTICLE TWO

The period of duration is perpetual.

ARTICLE THREE

The purpose or purposes for which the Corporation is organized are:

- (a) To engage in the business of licensed general contracting.
