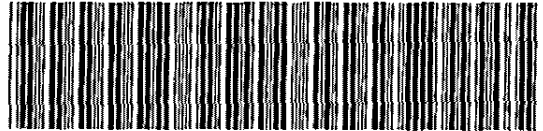

The power to adopt, alter, amend or repeal By-laws shall be vested in the Board of Directors, and the Shareholders.


**Article X - Indemnification**


