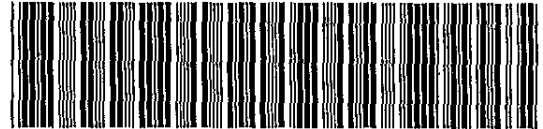

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is KC KUSTOMS, INC.

ARTICLE II

The street address of the principal office of the Corporation is 8255 West Sunrise Boulevard, #214 Plantation, Florida 33322.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 500, par value \$.01 per share, all of which shall be Common Shares. 
