#### ARTICLES OF INCORPORATION

OF

#### PERVIOUS PAVEMENT TECHNOLOGIES, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

> Article L Name.

The name of the Corporation is: PERVIOUS PAVEMENT TECHNOLOGIES, INC.

Article IL Duration.

The duration of the Corporation is perpetual.

Article III. Purpose,

The general purposes for which the Corporation is organized are the following
